Objective: UAM's SSEB offers high-quality courses taught in English by professors of the Faculty of Economics and Business Studies. B) Business Track: Two 6 ECTS credit courses are available (choose one or both):

1. Global Marketing

2. Doing Business in Spain

C) Mixed Track: Students can choose to take one course from each Track.

Credits: 6 or 12 ECTS

Duration: 4 weeks

Schedule: Classes take place from 9:30 a.m. to 1:30 p.m., Mondays through Fridays. Activities on some afternoons.

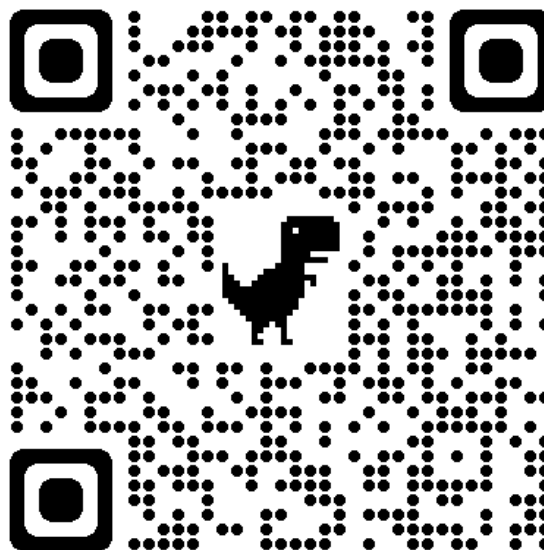
